Welcome Home Angel also provided sibling room makeovers and therapy/sensory rooms that enhanced childrens lives and well-being. Servicing southeastern NC and the Chicagoland area, Welcome Home Angel is expanding across the country to serve children ages 4-21 regardless of family income or diagnoses. In 2022, WHA impacted over 18 individuals across 5 families and home transformations.
